B Membership

(i) In order for Solicitors and Legal Executives to qualify for membership they must satisfy the following requirements:-

A practitioner must have either:-

- (a) gained **five years** relevant experience ("relevant experience" in this instance means that **50%** of the practitioner's year on year (ie unbroken) workload has over that period involved one or more of the areas of experience listed at 1A above); <u>or</u>
- (b) gained **ten years** relevant experience ("relevant experience" in this instance means that **25%** of the practitioner's year on year (ie unbroken) workload has over that period involved one or more of the areas of experience listed at 1A above).
- (c) NB In the case of an Associate Member applying for full membership, it is imperative that (1) contentious trust and probate work accounts for at least 50% of their active workload in the last two years, and (2) that this work will continue at that rate for the foreseeable future (see paragraph 2(g) above).
- (ii) In order for Barristers to qualify for Membership they must satisfy the following requirements:-

A practitioner must have either:-

- (a) 1(i)(a) or 1(i)(b) above; and must have
- (b) appeared in at least three contested hearings in the High Court, together involving at least three of the areas of experience listed at 1A above.

C Dates of experience

- (i) Any practitioner applying for Membership must have gained the years of the requisite years of relevant experience in the unbroken years immediately preceding the date of the application.
- (ii) All "relevant experience" must have been gained post-qualification.

2 **REGISTER OF MEMBERS**

The Association will keep details of Members to which other Members may refer.

COUNTER-SIGNATURE

The Head of the applicant's Department/Chambers should counter-sign the Declaration at Section 5 of the application form.

If the applicant is the Head of his/her Department/Chambers then the Declaration at Section 5 should in the case of solicitors be countersigned by the firm's Managing Partner, and in the case of barristers, the Declaration should be countersigned by a senior barrister from your Chambers of at least 20 years standing.
